We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2022-23 educational progress for Oakridge Middle School. For the 2022-23 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2022-23. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

We are excited to share that Oakridge Middle School has implemented a comprehensive school wide multiple tier system of supports to meet the varying needs of students. This system is set up to identify students' challenges, and implement systems of support to meet students' needs. Oakridge has adopted a district-wide reading initiative program to address student proficiency gaps. The key challenge remains getting as many students as possible to proficiency on both local and state assessments.

There are 18 teachers teaching at Oakridge Middle school, all teachers are certified and teaching within their certification.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

Students are assigned to the building by the appropriate grade level in which the building serves:

- Oakridge Lower Elementary K-3
- Oakridge Upper Elementary 4-6
- Oakridge Middle School 7-8
- Oakridge High School 9-12
- Oakridge Fusion High School 9-12

2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN

- a. A major implementation area for the 2022-2023 school year was the use of Star Math. Star Math finds and assists to close the gap on missing math skills that are essential for math comprehension.
- b. The district focused on creating a K-12 multi-tiered system of support for students and families in need of academic and/or behavioral support. We were very pleased to have several families serve on the committee to provide valuable stakeholder input. This is currently in the implementation phase.
- c. Eagle shout outs are a positive initiative to promote and celebrate positive behavior in the building. This Program is implemented in collaboration with the principal, teachers, psychologist, counselor, secretaries, and staff.
- d. A major focus area for the 2022-2023 school year was mathematics. A new curriculum was purchased K-12, extended day programs were made available to students, and many technology tools including classroom sets of scientific calculators were added to help support and lift instruction.

5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS:

NAEP Data (National Assessment of Educational Progress)

Overall on the M-Step, 22.9% of our 7th graders were proficient in Reading and 13.9% were proficient in Math.

Overall on the M-Step, 21.8% of our 8th graders were proficient in Science and 18.5% were proficient in Social Studies.

Overall on the NAEP, 25% of our 8th graders were proficient in Reading and 20% of our 8th graders were proficient in Math.

Overall on the PSAT, 45.5 of our 8th graders were proficient in Reading (EBRW) and 26.1% were proficient in Math.

6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

Fall 2022 conferences had 33% of parents represented and Spring 2023 conferences had 20% of parents represented.
