

MISSION STATEMENT

The mission of Oakridge Upper Elementary is to join parents and the community in providing a safe, supportive, challenging and inspiring environment which navigates a course toward Academic Excellence, Life-long Learning and Social Development.

Oakridge Upper Elementary School's Parental Involvement Policy is as follows:

1.
